



Player Membership Policy

Membership for Nottingham Dodgeball Club is renewed at the start of each season, usually on August 1st. This is done by completing a form and making the relevant membership payment.

There are 3 tiers of membership to choose from.

Social Membership- Free

Social membership includes access to sessions at a cost of £5 a session. Any new player that attends a session is automatically treated as this.

Student Membership- £10

Student membership includes access to sessions at a cost of £3 a session, members-only training sessions, entry into tournaments, entry into community league meetings and discounted socials. Additionally, this gives the option to pay for 10 sessions upfront, get 1 free. This also includes voting rights at the club AGM. This membership type is only valid for current students.

Club Membership- £15

Club membership includes access to sessions at a discounted cost of £4 a session, members-only sessions, entry into tournaments and league meetings, and discounted socials. Additionally this gives the option to pay for 10 sessions upfront, get 1 free. This also includes voting rights at the club AGM.

British Dodgeball membership

British Dodgeball membership allows you to access discounted coach education, discounted merchandise and voting rights at the British Dodgeball AGM and other benefits. British Dodgeball membership usually costs £15pp per year and can be added to any of the above memberships. This is necessary to compete in all British Dodgeball events. The club can manage your British Dodgeball membership purchase on your behalf, or you can purchase individually.

The recommended date for membership form returns is 1st August each year. However, there is no hard deadline for membership after this date. Membership purchased after this date will be reduced in price in line with the following:

- February-May - £10
- May - July - £5

The club committee reserves the right to refuse membership applications and cancel membership if individuals are found to have breached the club code of conduct.

Further membership information

Code of Conduct

Nottingham Dodgeball Club has a code of conduct that details what is expected of members and how members should act when representing the club. This must be adhered to at all times.

Membership Confirmation

Please note that you will not be a club member until your application has been approved and the necessary payment has been made. The club committee reserves the right to not accept an application for various reasons, although you are approved unless told otherwise.

Emergency Contact

Participating in dodgeball involves certain risks including the risks of physical injuries, damage to property and even death. Your emergency contact details will be stored securely and only used in the event of a serious injury or emergency.

Data Protection

Nottingham Dodgeball Club will collect and store some personal information to process your membership application and in case of emergencies. This data will be handled in accordance with the club data protection policy/ data declaration. Sometimes club members will need to contact each other for logistical purposes e.g. arranging transport to tournaments. Your data will be used in this way.

Media and Promotional Materials

Your image and likeness, and video may be used to promote the club unless you have informed the club that it should not be.

Data Declaration

1. Club Information

Nottingham Dodgeball Club is a British Dodgeball-affiliated club which provides dodgeball-based activity to its members.

2. Data Protection Information

The following Privacy Information is being provided to you as outlined in the General Data Protection Regulation. It is intended to inform you of how the personal information provided on this form will be used, by whom and for what purposes.

3. Data Controller:

The Data Controller for the club is the Secretary. They can be contacted by emailing Nottinghamdodgeball@gmail.com.

4. Purpose of processing Personal Information:

The purpose for processing your personal data is that it is necessary for the performance of a contract in order to register and maintain your membership with the club.

5. Data Processors:

Your personal data can be accessed by certain members of the club committee and will be done in accordance with our data protection policy only.

6. Storage of Personal Information:

Your data will be stored in a spreadsheet accessible to the committee.

7. Length of Data Storage:

Your personal data will be held for the duration of your membership and it will be deleted by us if you resign your membership.

8. Subject Access Request:

You have the right to request a copy of your personal data held by the club by contacting the Data Controller. You should receive this information within 30 days.

9. Personal Data Rights:


